

BRIDGEVIEW BANK EDGE CHECKING CONTEST TERMS AND CONDITIONS ("RULES")

1. To enter the Bridgeview Bank Edge Checking Contest, you must enter by the dates specified below and follow all Rules as set forth herein or as may be amended from time to time. No purchase is necessary to enter and no purchase will increase the chance of winning with an entry.
